- a. Parents are reminded that a full term's notice of intention to withdraw a child from the School must be given to the Headmaster in writing; unless such notice is given, fees for the following term must be paid.
- b. €290 Registration Fee includes: First Aid Services, Parents Association, Insurance, two School excursions and €60 for the Yearbook. In case of two or more children the first child will pay €290 and the rest €210 each, unless extra Yearbooks are ordered.
- c. Fees should be settled before the final examinations.
