Code of Conduct

1.1 Student Code of Conduct

All students are expected to uphold the following standards to ensure a positive, respectful, and productive school environment.

1.1.1 Respectful and Positive Attitude

- Treat all members of the school community—including peers, teachers, and staff—with kindness, respect, and tolerance.
- Value and appreciate differences in backgrounds, opinions, and beliefs.
- Always use polite and appropriate language.
- Address teachers and staff formally (e.g., by title and surname).

1.1.2 Attendance and Punctuality

- Attend all classes regularly and arrive on time to show commitment to your learning.
- Avoid unnecessary absences. If absent due to illness or other serious reasons, inform the school as soon as possible.

1.1.3 Dress Code and Personal Grooming

- Wear the correct school uniform properly and with pride.
- Follow all school guidelines regarding grooming, hairstyles, shaving, and jewellery.
- Always maintain a neat and clean appearance.

1.2 Academic Integrity: Plagiarism and Cheating

At our school, we value honesty, responsibility, and fairness in all academic work. All students are expected to complete their work independently and uphold the highest standards of integrity.

Plagiarism is when a student presents someone else's work, ideas, or words as their own without giving proper credit. This includes copying from books, websites, classmates, or using Al-generated content without permission or citation.

Cheating is any action intended to gain an unfair advantage in schoolwork or exams. This includes, but is not limited to:

- Copying during a test or exam
- Using unauthorized materials
- Submitting work done by someone else (including AI tools, family members, or friends)
- Sharing answers or test content with others

These actions go against our school's values and are taken seriously.

Consequences of plagiarism or cheating may include:

 Disciplinary action, according to the Discipline Policy Table, and always depending on the severity and repetition

Using AI tools: The usage of AI tools must be used in an ethical manner and based on academic integrity, as outlined in the AI Policy of our school.
